2. Evaluation of the whole agency

• In its activities in FY2017, RIKEN produced remarkable research and development achievements that lead the world in each research field, including emergent matter science research, which is expected to be widely applied to industry, and therefore, it is evaluated that the agency is proceeding with plans for maximization of the R&D achievements.

(Examples of remarkable research and development achievements in FY2017)

- Emergent matter science research: Development of an unprecedented material with rigidity equal to that of plastic and, at the same time, capable of self-restoring from damage, accomplishment of the world's highest accuracy in quantum manipulation in quantum dots, accomplishment of quantized anomalous hall effect at a high temperature region in magnetic topological insulators, and demonstration of topological current in a domain wall structure for the first time in the world are highly evaluated.
- Brain science research: Clarification of the mechanisms that sleeping helps new memory formation and that short-term memory formed in hippocampus is transmitted to cerebral cortex and fixed for a long time, clarification of partial mechanism of having an onset of autism, and improvement of abnormal behavior with mice are highly evaluated.
- Integrative medical science research: Disclosure of approximately 1,000 pieces of genome-wide sequence data in collaboration with domestic agencies, identification of genes relating to cerebral stroke and multifactorial disorder by genomic analysis, commencement and steady development of the world's first phase I clinical trial using artificial adjuvant vector cells, and successful development of a drug for treating leukemia that eradicates about 80 percent of leukemia cells using humanized mice with acute myeloid leukemia are highly evaluated.
- Synchrotron radiation science research: A high use rate of SPring-8 by private industry (about 20%), contribution to the application of R&D results to society including development of the highest grade, low-fuel consumption tires, etc., preparation of an experimental environment of SACLA in which three XFEL beam lines can be used simultaneously by achieving the operation of hard X-ray FEL beam lines by domain of pulses, and a high use rate of SACLA, about 87% to the total operation time, are highly evaluated.
- Bio resource project: Elimination of wrong samples and contamination of samples due to sophisticated quality inspection and accomplishment of 0% in recall rate following last fiscal year, and the number of supplies exceeding the target value are highly evaluated for the agency which needs to maintain high levels in both quality and quantity as an agency designated as one of three major bases in the world for all bio-resources it provides.

• Regarding items related to management, such as streamlining business operations, it can be evaluated that steady efforts are underway generally as planned.
