Promoting freedom of expression and reinforcing media to address the crisis

- **World Press Freedom Day 2020 campaign focused on the role of free and independent media in providing verified, accurate and life-saving information in times of crises**
- **Four IPDC projects supporting media to respond to COVID-19 in Eastern and Southern Africa, India and Eastern Caribbean SIDS**
- **Development of a MOOC to build capacities of journalists to cover the COVID-19 pandemic professionally and safely**
- **UNESCO statement on the importance of ensuring safety of journalists amid the COVID-19 pandemic**

- **Policy briefs on disinformation on COVID-19, setting out the issue and analyzing responses, with concrete recommendations**
- **#DontGoViral campaign to crowdsource local openly licensed content to inform communities across Africa about COVID-19**
- **Audio messages for radio and other MIL-related resources to counter disinformation and promote healthy behaviours**
- **Possibility for large scale projects focusing on media and citizens to combat disinformation on COVID-19**
