

# 6<sup>TH</sup> Australia-Japan High Level Policy Dialogue on Education JOINT SUMMARY Canberra Australia, 8 July 2022

- 1. The 6<sup>th</sup> Australia-Japan High Level Policy Dialogue on Education was held on 8 July 2022 in Canberra, Australia, in accordance with the *Memorandum of Cooperation in Education* between the Australian Government Department of Education (DE) and the Japanese Ministry of Education, Culture, Sports, Science and Technology (MEXT), originally signed in 2007 and renewed on 4 December 2018.
- 2. Our two countries decided at the Japan-Australia Leaders Meeting held on 24 May 2022, to strengthen the *Special Strategic Partnership* between Japan and Australia and realise a free and open Indo-Pacific. Promotion of both inter-university and research organisation exchange and student/researcher exchange, in accordance with the discussion in the Dialogue, will further strengthen the Japan-Australia relationship.
- 3. The Dialogue was co-chaired by Ms Karen Sandercock, First Assistant Secretary of International Division, DE, and Ms OKAMURA Naoko, Director-General for International Affairs, MEXT. Japan's delegation included representatives of the Japan Science and Technology Agency (JST), the Japan Agency for Medical Research and Development (AMED) and the Japanese Embassy in Australia. Australia's delegation included representatives of DE, the Department of Industry, Science and Resources (DISR), the Australian Tertiary Education Quality and Standards Agency (TEQSA), the Australian Research Council (ARC) and the National Health and Medical Research Council (NHMRC). - 4. The Dialogue focused on initiatives to build on the already substantial education and research relationship between Australia and Japan. Participants reaffirmed this deep and long-standing relationship and recognised its enduring social, cultural and economic benefits for both countries.
- 5. Officials exchanged notes on pandemic-related challenges affecting education and research, and on their experience with recovery strategies surrounding the reopening of international borders. A key focus was emerging priorities and post-pandemic opportunities for improving international education, including by expanding international partnerships. Officials specifically discussed online quality assurance, post-pandemic international strategies in both countries, and also deepened understanding of the mutual challenges both countries confront.
- 6. Acknowledging the significant impact of the COVID-19 pandemic on the international education sector over the preceding three years, officials were pleased to have been able to meet in person to share experiences and plan for future engagement. Officials shared expectations that

outcomes from the Dialogue promote exchange among universities, students and relevant education organisations in both countries, which was disrupted during the pandemic.

- 7. Officials affirmed the significance of the QUAD fellowship and shared a common understanding of the importance of encouraging mutual exchange through the QUAD fellowship.
- 8. Officials discussed research security and integrity, sharing information on relevant domestic measures and acknowledging challenges.
- 9. Officials committed to a series of education and research thematic roundtable events which would be supported by Australian and Japanese government agencies, to connect universities and industry representatives of both countries.
- 10. Officials discussed research collaboration arrangements, including Japan's Strategic International Collaborative Research Program (SICORP), currently in place with several other countries. Officials noted that great potential exists for further research collaboration in shared priority research areas. Identifying some specific examples of existing collaboration, participants also discussed how to promote more of this valuable form of cooperation. The Dialogue also saw a fruitful discussion of industry-academia collaboration.
- 11. Officials acknowledged the importance of the bilateral education and research relationship and shared a common understanding of the necessity for a plan for further work between MEXT and DE. In doing so, officials acknowledged the long-term value of the Australia Japan Education staff exchange program. DE welcomed MEXT's proposal to send an official to DE when safe to do so.
- 12. Officials agreed to hold the next High Level Policy Dialogue meeting in a timely and appropriate manner in light of the rapidly changing world and the importance of international education, utilising online meeting tools where convenient.
- 13. Japan will host the next High Level Policy Dialogue meeting at a time to be mutually determined.
