**KAMEI Haruko**

Director General, Human Development Department, Japan International Cooperation Agency (JICA)

Since she joined JICA in 1998, she served in several positions including Chief Representative of JICA Cambodia Office, Deputy Director General of Governance and Peace Building Department, Senior Director for Office of Gender Equality and Poverty Reduction, Director for South Asia Division responsible for operations in Sri Lanka and Maldives, Director for Basic Education Section.

After working at Ministry of International Trade and Industry and serving as the associate professor at Keio University, he spent the following 12 years as a member of the House of Councilors.
