基本的な事項

- ・米国では憲法によって、教育に関する権限は連邦ではなく州(および人民)に留保されている。高等教育も同じ
- 教育機関の正統性の担保(設置および設置の認可)は第一義的に州の責任→合衆国レベルでは提供される教育に多様性
- ・ これによって発明されたシステムが教育機関相互の自発的適格認定(アクレディテーション)

1847年:アメリカ医学協会(最初のアクレディテーション団体)発足

1885年:ニューイングランド協会(最初の地域アクレディテーション団体)発足

→当初は中等教育までを対象


1913年:北中部協会が初の大学基準公開

1965年:高等教育法制定(連邦による学生奨学金受給制度本格開始)

1968年:連邦によるアクレディテーション団体の認証開始(適格認定と連邦奨学金制度紐

づけ)

機関別アクレディテーションの「地域」



- 第1次トランプ政権で「地域」を超えた機関別アクレディテーションも可能に
- 第2次トランプ政権開始前に機関アクレディテーションの越境はじまる(例外的)
- 第2次トランプ政権が地域の「硬直的実態」を批判(本報告では2024年までの状況を対象)₃

米国のアクレディテーション

- 新たな社会問題を、新たな制度を自発的に開発して解決する米国式アプローチの好例(Harcleroad, 1980)→アンブレラ団体としてのCHEAの役割→アクレディテーション団体と高等教育機関は同業者であり相互に敬意を払う(適格認定のミーティングでは大学は起立して迎えられる)
- アクレディテーションを受けている機関が正統な機関⇔受けていなければディプロマ・ミル
- 大学の自発的な質保証の仕組みを奨学金支給などのために連邦が利用しているという建前



- 機関別で認定されていない大学はない(正当な大学とみなされない) ⁶

まとめと疑問ーWGの趣意に寄せて

- ・米国のアクレディテーションは同業者の自発性にもとづくもので相互に敬意を払うことが基本
- 機関別アクレディテーションは高等教育機関の正統性の基本
 - 連邦教育省による一元的な設置認可がない米国の現状では、これがなくてもいいという 発想は生まれない
- 分野別アクレディテーションは当該分野の専門家が立ち上げて専門家が運営
 - それゆえの相互的敬意
 - 専門性の低い組織が運営する分野別アクレディテーションに国際的な通用性が生まれる かは大いに疑問
 - 専門性の低い組織が運営する分野別アクレディテーションがあって機関別アクレディテーションのない高等教育機関に国際的な通用性が生まれるかも疑問
- 常に「アメリカみたいにしていればいい」わけでは決してない
 - 機関別アクレディテーションが固より存在しなかったのではなく、あるとき日本の全ての 高等教育機関がそれを失うなら、その国際的なインパクトは? 個別機関の瑕疵でない ことの説明は?
