#### **SUMMARY**

In accordance with Sections 8.5.1.1 and 8.5.3.5.4 of the General Guidelines of the Memory of the World (MOW) Programme as approved by the Executive Board at its 211th session (211 EX/Decision 10) and with reference to document 221 EX/17, the list of the nominations of the 74 new items of documentary heritage to be inscribed on the Memory of the World International Register decided upon by the International Advisory Committee of the Memory of the World Programme at its fifteenth ordinary session held from 26 to 28 February 2025, are contained in the present information document.

This information document also includes information on the progress of the dialogue on all ongoing contests, in accordance with Section 8.6.5.2.7 of the General Guidelines of the MOW Programme.



#### **INTRODUCTION**

- 1. In its 211 EX/Decision 10, the Executive Board approved the revised General Guidelines of the Memory of the World (MoW) Programme (hereinafter "General Guidelines") as well as the amended Statutes of the International Advisory Committee (IAC) of the MoW Programme (hereinafter "Statutes").
- 2. The IAC comprises 14 international experts, chosen for their expertise in safeguarding documentary heritage. The members of the IAC are appointed by the Director-General and serve in a personal capacity, not as representatives of States or any other affiliated entities. They will not seek or accept instructions from governments or other authorities.
- 3. In line with Article 2 of the Statutes and Section 5.1.1 of the General Guidelines, the IAC is responsible for advising UNESCO on the planning and implementation of the MoW Programme as a whole. Its responsibility includes recommending documentary heritage for inscription on the Memory of the World International Register as specified in Article 2 of the Statutes and Section 8 of the General Guidelines. In particular, according to Section 8.5.3.5.4 of the General Guidelines, the IAC will recommend to the Director-General to include an item on the agenda of the Executive Board which will propose that the Executive Board endorse the nominations decided upon by the IAC for items to be inscribed on the Memory of the World International Register.
- 4. At its fifteenth ordinary session held from 26 to 28 February 2025 at the IIEP-UNESCO (International Institute for Educational Planning) in Paris, France, the IAC assessed 119 new nominations submitted by Member States and International Organizations, regarding various items of documentary heritage for possible inscription on the Memory of the World International Register.

#### **ONGOING CONTESTS**

5. Altogether, 122 nominations were received. Three of these were contested and are now a subject of dialogue by the Member States concerned.

#### **NOMINATED ITEMS**

6. The IAC decided to nominate the following 74 new items of documentary heritage to be inscribed on the Memory of the World International Register for the 2024-2025 nomination cycle, which are now submitted to the Executive Board for its endorsement (see document 221 EX/17). The titles and submitters of these nominations are presented below while their corresponding explanatory details, as submitted by the nominators and reviewed by the IAC, are summarized online at: https://unesdoc.unesco.org/ark:/48223/pf0000392639
