Ordinance for Enforcement of the Act on Regulation of Human Cloning Techniques

Ordinance of the Ministry of Education, Culture, Sports, Science and Technology (MEXT)
No. 25 of May 20, 2009

(Notification of Production of Specified Embryos)

Article 1 (1) Notification of the production of specified embryos pursuant to Article 6, Paragraph (1) of the Act on Regulation of Human Cloning Techniques (hereinafter referred to as the “Act”) shall be made using the appended form No. 1-1 when producing human somatic cell nuclear transfer (hSCNT) embryos and using the appended form No. 1-2 when producing animal-human chimeric embryos, respectively.

(2) Of matters prescribed in the Ordinance of the Ministry of Education, Culture, Sports, Science and Technology under Article 6, Paragraph (1), Item (vi) of the Act, those matters pertaining to the production of specified embryos are as follows:

- (i) Matters pertaining to the necessity of utilizing specified embryos for research
- (ii) Matters pertaining to the technical capability of a person who intends to produce specific embryos (hereinafter in this item and the following paragraph, referred to as a “producer”) and the management capability of the producer when it is intended to produce hSCNT embryos
- (iii) The place where specified embryos are produced
- (iv) The place where specified embryos are handled
- (v) The type, source, method of transportation of cells to be utilized in the production of specified embryos and estimated amount of expenses necessary to acquire the cells as well as, when it is intended to produce hSCNT embryos, the method to acquire the cells
- (vi) The method to take somatic cells from human body, when being donated with newly taken somatic cells to utilize in the production of hSCNT embryos (limited to cells that are taken with a minimum influence on the donors’ body), and any physical influence that can be caused on donors when cells are taken, along with compensation for such physical influence if any
- (vii) Of matters pertaining to consent of the donor who donates cells to be utilized in the production of specified embryos, matters corresponding to the following:

- (a) The name and title of the person who makes explanation concerning the consent to be given and, when it is intended to produce hSCNT embryos, the name of the organization to which the person belongs
 - (b) The name of an institute that obtains such consent, when it is intended to produce hSCNT embryos
 - (c) The time period until the donor should make response concerning his/her consent, when it is intended to produce animal-human chimeric embryos
 - (d) The time period during which the donor can revoke his/her consent and a method for such revocation, when it is intended to produce hSCNT embryos
 - (e) Matters pertaining to the protection of the donor's personal information
 - (viii) The name of the institutional ethical review board or the ethical review board that has been consulted (hereinafter simply referred to as an "ethical review board"), its members and the members' specialized fields
 - (ix) Opinions provided by the ethical review board
- (3) Notification prescribed in the Paragraph (1) above shall be attached with a document that describes matters related to an explanation to be offered to the donor which should be made by the producer or a person belonging to the somatic cell donor facility (a facility that receives donations of human somatic cells to be used for the production of specified embryos and transfer such somatic cells to a producer), when obtaining consent from the donor of cells as well as with a drawing that shows places where such specified embryos are produced and handled after production, when it is intended to produce hSCNT embryos.

(Notification of Receipt by Assignment of Specified Embryos)

Article 2 (1) Receipt by assignment of specified embryos prescribed in Article 6, Paragraph (1) of the Act shall be notified using the appended form No. 1-3 when it is intended to receive by assignment hSCNT embryos and using the appended form No. 1-4 when it is intended to receive by assignment animal-human chimeric embryos, respectively.

(2) Of matters prescribed in the Ordinance of MEXT under Article 6, Paragraph (1), Item (vi) of the Act, matters concerning the receipt by assignment of specified embryos are as follows:

- (i) Matters concerning the necessity of utilizing specified embryos for research
- (ii) Matters concerning the technical capability of a person who intends to receive by assignment specified embryos (hereinafter in this item, referred to as a "receiver")

and the management capability of the receiver, when it is intended to receive by assignment hSCNT embryos

- (iii) The place to receive by assignment hSCNT embryos, when it is intended to receive hSCNT embryos
- (iv) The place to handle the specified embryos after receipt by assignment
- (v) The method to transport animal-human chimeric embryos and the estimated amount of expenses necessary for receipt by assignment, when it is intended to receive by assignment animal-human chimeric embryos
- (vi) The name and domicile of a person who produced the specified embryos and, in case of a juridical person, the name of its representative
- (vii) The date on which the notification of production was made with respect to the specified embryos
- (viii) The name of the ethical review board, its members and the members' specialized fields
- (ix) Opinions provided by the ethical review board

(3) When it is intended to receive by assignment hSCNT embryos, the notification prescribed in Paragraph (1) above shall be attached with a drawing that shows the place to receive by assignment such hSCNT embryos and the place to handle such embryos after receipt by assignment as well as a drawing that shows the positional relations between those places and the place to produce the hSCNT embryos.

(Notification of Change of the Previous Notification of Production or Receipt by Assignment of Specified Embryos)

Article 3 Any change of a previous notification prescribed in Article 6, Paragraph (2) of the Act shall be notified using the appended form No. 2.

(Notification of Production of Specified Embryos by Chance Cause)

Article 4 (1) Notification prescribed in Article 9 of the Act shall be made using the appended form No. 3.

(2) Matters prescribed in the Ordinance of MEXT under Article 9, Item (iv) of the Act shall be as follows:

- (i) The place where the specified embryos were generated
- (ii) The status of the generation of such specified embryos

- (iii) The method to handle the generated specified embryos
- (iv) The place where the generated specified embryos are handled

(Making, etc. of Records)

Article 5 (1) Records prescribed in Article 10, Paragraph (1) of the Act shall be made and preserved in writing, magnetic tape or other media.

(2) When the records described in the preceding paragraph are made and preserved in an electromagnetic method (an electronic, magnetic or any other method not recognizable to by human perception), such records shall be able to be displayed immediately as necessity arises with the use of computer or other equipment.

(3) Matters prescribed in the Ordinance of MEXT under Article 10, Paragraph (1), Item (iv) of the Act shall be as follows:

- (i) The place where the specified embryos were produced
- (ii) The place where the specified embryos that were produced or received by assignment are handled
- (iii) The source of cells that were utilized in the production
- (iv) Matters related to the consent of the donor who donated cells for the production
- (v) The purpose, method, freezing period and place and method of management as well as the name of the person engaged in the management, when the specified embryos were frozen

(4) The time period during which the records should be preserved under Article 10, Paragraph (2) of the Act shall be 5 years after the production or receipt by assignment of the relevant specified embryos.

(Notification of Assignment of Specified Embryos)

Article 6 (1) Assignment of specified embryos prescribed in Article 11 of the Act shall be notified using the appended form No. 4-1 when hSCNT embryos are assigned and using the appended form No. 4-2 when animal-human chimeric embryos are assigned, respectively.

(2) Of matters prescribed in the Ordinance of MEXT under Article 11, Item (iv) of the Act, matters pertaining to the assignment of specified embryos shall be as follows:

- (i) The date on which the notification of production or receipt by assignment was made with respect to the assigned specified embryos

- (ii) The name and domicile of the receiver of specified embryos and, in case of a juridical person, the name of its representative
- (iii) The reason for assignment
- (iv) The place of assignment, when hSCNT embryos are assigned
- (v) The method and expenses for transporting animal-human chimeric embryos, when such embryos are assigned

(Notification of Destruction of Specified Embryos)

Article 7 (1) Destruction of specified embryos prescribed in Article 11 of the Act shall be notified using the appended form No. 4-3.

(2) Of matters prescribed in the Ordinance of MEXT under Article 11, Item (iv) of the Act, matters pertaining to destruction of specified embryos shall be as follows:

- (i) The place where specified embryos were destroyed
- (ii) The date on which the notification of production or receipt by assignment was made with respect to the destroyed specified embryos
- (iii) The reason for and method of the destruction
- (iv) Matters related to the handling after such destruction

(Notification of Disposal of Specified Embryos)

Article 8 (1) Disposal of specified embryos prescribed in Article 11 of the Act shall be notified using the appended form No. 4-4.

(2) Of matters prescribed in the Ordinance of MEXT under Article 11, Item (iv) of the Act, the matters related to the disposal of specified embryos are as follows:

- (i) The place where specified embryos were disposed of
- (ii) The date on which the notification of production or receipt by assignment was made with respect to the disposed of specified embryos
- (iii) The reason for and method of the disposal

(Number of Copies of Notification to Submit)

Article 9 (1) The number of copies of notification prescribed in Article 1, Paragraph (1), Article 2, Paragraph (1), Article 3, Article 4, Paragraph (1), Article 6, Paragraph (1), Article 7, Paragraph (1) and Article 8, Paragraph (1) to submit shall be the 1 original and its 3 duplicate copies, respectively. With respect to notification prescribed in Article 1,

Paragraph (1) and Article 2, Paragraph (1), however, of the 3 duplicate copies, 2 copies shall not need to be attached with a document and a drawing prescribed in Article 1, Paragraph (3) and a drawing prescribed in Article 2, Paragraph (3), respectively.

(Procedures Using Flexible Disk)

Article 10 With respect to documents prescribed in each of the following items, submission may be deemed to be made by submitting flexible disks that record matters to be described in the relevant document and a flexible disk submission slip that was prepared using the appended form No. 5 (in the following paragraph, referred to as a “flexible disk, etc.”).

- (i) Article 1, Paragraph (1)
- (ii) Article 2, Paragraph (1)
- (iii) Article 3
- (iv) Article 4, Paragraph (1)
- (v) Article 6, Paragraph (1)
- (vi) Article 7, Paragraph (1)
- (vii) Article 8, Paragraph (1)

(2) When submitting a flexible disk, etc. instead of submitting a document prescribed in each of the above items of the preceding paragraph in accordance with the provisions of the same paragraph, “the original and 3 duplicate copies” prescribed in the preceding article shall be replaced with “1 copy of flexible disk and 4 copies of flexible disk submission slips.”

(Structure of Flexible Disk)

Article 11 A flexible disk prescribed in the preceding article, Paragraph (1) shall correspond to either of the following:

- (i) A 90 mm flexible disk cartridge that conforms to Japanese Industrial Standards X6221 based on the Industrial Standardization Act (Act No. 185 of 1949) (hereinafter simply referred to as the “Japanese Industrial Standards”), or
- (ii) A 90 mm flexible disk cartridge that conforms to Japanese Industrial Standards X 6223

(Recording Method for Flexible Disk)

Article 12 (1) Recording onto a flexible disk as prescribed in Article 10, Paragraph (1) above shall be carried out by the following methods:

- (i) For a track format, the method specified in Japanese Industrial Standards X6222 when recording onto a flexible disk as prescribed in Item (i) of the preceding article, or the method specified in Japanese Industrial Standards X6225 when recording onto a flexible disk as prescribed in Item (ii) of the preceding article
- (ii) For a volume and file configuration, the method specified in Japanese Industrial Standards X0605
- (iii) For character coded representation, the method specified in Annex 1 to Japanese Industrial Standards X0208

(2) Recording onto a flexible disk prescribed in Article 10, Paragraph (1) shall be carried out by using those graphic characters specified in Japanese Industrial Standards X0201 and X0208 and the “Carriage Return (CR),” and the “Line Feed (LF)” from among those control characters specified in Japanese Industrial Standards X0211.

(Document to be Pasted onto Flexible Disk)

Article 13 A label stating the following particulars shall be attached to the labeling area specified in Japanese Industrial Standards X6221 or X6223 of a flexible disk as prescribed in Article 10, Paragraph (1):

- (i) The name of notification to submit
- (ii) The name of the person who makes notification and, in case of a juridical person, the name of its representative
- (iii) The date of submission

Supplementary Provision

This Ordinance shall come into effect as of the date of promulgation.
